# STUDENT CALL FOR APPLICATIONS Apple Programs Participants

Document reference: AppleDeveloperAcademyProgramsParticipantsCall\_24\_25

**GIVEN** the Law of August 2nd, 1990, n. 241 "Nuove norme in materia di procedimento amministrativo e di diritto di accesso ai documenti amministrativi" "New regulations on administrative procedures and the right of access to administrative documents"] and subsequent amendments and/or additions;

**GIVEN** the applicable University Statute:

**GIVEN** the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data - hereinafter EU Regulation 2016/679 - relating to the protection of individuals with regard to the processing of personal data, and the related National legislation of the Code regarding the protection of personal data, Legislative Decree N. 196/2003, as modified and integrated by Legislative Decree No. 101/2018;

**CONSIDERING** the Regulation of the University of Naples Federico II regarding the processing of personal data, issued with D.R. 1226/2021;

considering the Scientific and Technological Cooperation Agreement signed between University of Naples Federico II and Apple, for the establishment of the Developer Academy, for the training in the development of new applications and digital services, with the purpose – among others – to provide students admitted to the Apple Developer Academy with the necessary skills to become "developers" of innovative apps, i.e., professionals who can design, implement and commercialize innovative services on Apple technological platforms;

**CONSIDERING** that, as provided for by the aforesaid Scientific and Technological Cooperation Agreement and the Exhibit A – Project Addendum 1, the students will be admitted to the













Apple Developer Academy after passing a specific selection;

- **GIVEN** the Administration Board decree of 25<sup>th</sup> July 2016 and subsequent with which the administrative and accounting management has been entrusted to the Centro di Servizio di teneo per il Coordinamento dei Progetti Speciali e l'Innovazione Organizzativa dell'Università degli Studi di Napoli Federico II COINOR;
- **GIVEN** the public notice of the Campania Region "Borse di studio per frequenza di academies regionali di livello internazionale in ambito ICT e digitale" ["Scholarships for attendance of regional academies of international level in ICT and digital"] D.D.n.206 of 20/07/2022 BURC n.64/2022;
- **CONSIDERING** that in response to the aforementioned Notice, the University of Naples Federico II presented the project DEFER Developers For Ever aimed at the implementation of highly qualifying training paths able to provide and strengthen digital skills and abilities of the recipients for an access or re-employment in the labor market;
- **GIVEN** the Executive Decree of the Campania Region No. 247 of 16/09/2022 by which the ranking list for the Public Notice "Borse di studio per frequenza di academies regionali di livello internazionale in ambito ICT e digitale" ["Scholarships for attendance of regional academies of international level in ICT and digital"] was approved;
- **CONSIDERING** that the Executive Decree No. 302 of 02/11/2022 the Project "DEFER Developers For Ever" has been admitted for funding from the PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5, for a total amount of € 8,400,000.00 (eight million four hundred thousand/00 euros);
- **CONSIDERING** the Convention between the University of Naples Federico II and the Campania Region signed on January 16, 2023 for the implementation of the project "DEFER Developers for ever" (CUP E64C22001210006 CML 22021PP0000001);
- **CONSIDERING** also that, for the academic year 2024/2025 it is expected that a total number of 300 students will be admitted to the Developer Academy, of which 80 seats are for those who have already attended the Apple Foundation Program, or the Apple Developer Academy in Brazil, Indonesia, Kingdom of Saudi Arabia, South Korea, or USA, or the iOS Development Lab in Mexico. This set of applicants will be collectively referred to as "Apple Programs Participants" in the remainder of this document.













#### **DECLARES**

### SECTION 1 (Announcement and number of seats)

As part of the project "DEFER - Developers for Ever" (CUP E64C22001210006 - CML 22021PP0000001) eligible for funding from PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5, the University of Naples Federico II announces a selection of 80 students to be admitted to the Apple Developer Academy.

The selection refers to the academic year 2024/2025.

### SECTION 2 (Requirements for participation)

In order to be eligible for the selection mentioned in section 1, applicants:

- must have attended and completed the Apple Foundation Program, or the Apple Developer Academy in Brazil, Indonesia, Kingdom of Saudi Arabia, South Korea, or USA, or the iOS Development Lab in Mexico;
- must be 18 years old by the Apple Developer Academy' starting date, September 23rd, 2024.

Candidates get provisional admission to the selection. The University might decide to exclude any candidate, at any stage of this selection procedure, if the requirements are not fully met.

The applicants must not have already attended the Apple Developer Academy in Naples in the academic years 2016/2017, 2017/2018, 2018/2019, 2019/2020, 2021/2022, 2022/2023, 2023/2024.

## SECTION 3 (Application for participation in the selection procedure)

The application form must be submitted exclusively online through the following website: https://www.developeracademy.unina.it.

The online registration is available since the publication date of this announcement and will close mandatorily (and under penalty of exclusion from the selection procedure) **at 9am (GMT+1) of February 26**<sup>th</sup>, **2024.** Any "Apple ProgramsParticipants" applicant who is not accepted can still apply to the Academy through the standard application process as described in the call for applications and the related Annex A.













Failure to comply with the regulations described in section A.2 of Annex A will prevent admission to the selection and, in any case, result in exclusion from the procedure.

All communications concerning the selection will be given exclusively via online publication on the Official Noticeboard of the University of Naples Federico II (available on the University website <a href="https://www.unina.it">https://www.unina.it</a>), as well as by publication on the website <a href="https://www.developeracademy.unina.it">https://www.developeracademy.unina.it</a>.

### SECTION 4 (Evaluation Committee)

The Evaluation Committee will be appointed after the final deadline for submission of the applications. Its composition will be announced through a notice, published exclusively in the Official Noticeboard of the University (available at <a href="https://www.unina.it">https://www.unina.it</a>) and on the website https://www.developeracademy.unina.it.

### SECTION 5 (Selection procedure)

The admission exam will be in English and will consist in an interview.

#### **SECTION 6**

(Admission test: date and place of the interview - implementation procedure)

The date and time of the interview will be made known exclusively by online publication on the Official Noticeboard of the University of Naples Federico II (available at <a href="https://www.unina.it">https://www.unina.it</a>) and by publication on the website <a href="https://www.developeracademy.unina.it">https://www.developeracademy.unina.it</a>)

The interview will take place online (via video conference), in accordance with the procedures mentioned in section A.3 of Annex A.

The interview will take place within March 5<sup>th</sup>, 2024.

### SECTION 7 (Publication of the ranking list)

The merit ranking list will be drawn up only based on the scores obtained in the interview.

In the event of a tie, the younger candidate shall prevail. The final ranking list will be published in the













Official Noticeboard of the University of Naples Federico II (available at <a href="https://www.unina.it">https://www.unina.it</a>) and on the web site <a href="https://www.unina.it">www.developeracademy.unina.it</a>.

The final ranking will be published within March 8<sup>th</sup>, 2024.

Applicants who do not rank among the admitted 80 participants, can still apply for the Apple Developer Academy in accordance with the standard selection procedure described in point A.2 of the Annex A (Rif.AppleDeveloperAcademyCall\_24\_25).

The standard application process ends March 25<sup>th</sup>, 2024. Unsuccessful candidates will hence need to act promptly if they wish to re-apply through the standard application process.

The selection procedure refers only to academic year 2024-2025.

## SECTION 8 (Economic support funds)

No. 220 scholarships are provided for attendance to the Apple Developer Academy, which can be increased up to a maximum of 300, in the event that the number of students admitted through the selection procedure "Apple Programs Participants" (Ref: AppleDeveloperAcademyProgramsParticipants\_24\_25) is less than 80, from the PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5.

The gross amount of each scholarship is  $\in$  7,777.78 (Euro seven thousand seven hundred and seventy-seven/78) corresponding to a gross percipient of  $\in$  7,168.46 (Euro seven thousand one hundred and sixty-eight/46), to be paid in the form of an Attendance Allowance provided that the participant has attended at least 80% of the total number of hours scheduled for the training course equal to 750.

## SECTION 9 (Procedure of acceptance)

The candidates admitted have to formalize, at latest by March 15<sup>th</sup>, 2024, their attendance to the Apple Developer Academy by signing a declaration of acceptance by which the admitted person undertakes to comply with the provisions of this selection notice.

Once the deadline for acceptance has expired, if there are any seats left due to lack of acceptance or subsequent withdrawal, the ranking will be scrolled. Any scrolling and the relative terms for making acceptances will be made known exclusively through publication on the website of the University of Naples Federico II. Scrolling procedures will finish mandatorily by March 22<sup>nd</sup> 2024. After that date, the only procedure that stays open is the standard call for applications.













## SECTION 10 (Publication of the procedural acts)

This notice of selection and all documents attached will be published exclusively by online posting in the Official Noticeboard of the University of Naples Federico II (available on the website https://www.unina.it) and by publication on the website https://www.developeracademy.unina.it.

The online publication in the Official Noticeboard of the University of Naples Federico II has the force of notification with all effects and no personal messages will be sent to interested parties. Therefore, it is recommended a constant consultation of the web links above.

For information purpose only, applicants might also want to keep an eye on the official Academy social media platforms such as Instagram or Facebook where regular updates and news are also posted.

### SECTION 11 (Access to documents, Information regarding personal data)

Applicants have access to documents concerning the competition procedure, in accordance with the current legislation. This right will be exercised in the manner prescribed by the University Regulations laying down the rules on administrative procedure and the right of access to documents, issued with the Dean Decree n. 2294/2010 and subsequent amendments and additions.

## SECTION 12 (Privacy and information on personal data)
