## STUDENT CALL FOR APPLICATIONS Apple Developer Academy Document reference: AppleDeveloperAcademyCall 24 25

- **GIVEN** the Law of August 2nd, 1990, n. 241 "Nuove norme in materia di procedimento amministrativo e di diritto di accesso ai documenti amministrativi" ["New regulations on administrative procedure and the right of access to administrative documents"] and subsequent amendments and / or additions;
- GIVEN the applicable University Statute;
- **GIVEN** the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data hereinafter EU Regulation 2016/679 relating to the protection of individuals with regard to the processing of personal data, and the related National legislation of the Code regarding the protection of personal data, Legislative Decree N. 196/2003, as modified and integrated by Legislative Decree No. 101/2018;
- **CONSIDERING** the Regulation of the University of Naples Federico II regarding the processing of personal data, issued with D.R. 1226/2021;
- **CONSIDERING** the Scientific and Technological Cooperation Agreement signed between University of Naples Federico II and Apple, for the establishment of the Apple Developer Academy, for the training in the development of new applications and digital services, with the purpose among others to provide students admitted to the Apple Developer Academy with the necessary skills to become "developers" of innovative apps, i.e., professionals who can design, implement and commercialize innovative services on Apple technological platforms;

CONSIDERING that, as provided for by the aforesaid Scientific and Technological Cooperation





Agreement and the Exhibit A – Project Addendum 1, the students will be admitted to the Apple Developer Academy after passing a specific selection;

- **GIVEN** the Administration Board decree of 25th July 2016 and subsequents with which the administrative and accounting management of the Apple Developer Academy courses has been entrusted to the "Centro di Servizio di Ateneo per il Coordinamento dei Progetti Speciali e l'Innovazione Organizzativa dell'Università degli Studi di Napoli Federico II COINOR;
- **GIVEN** the public notice of the Campania Region "Borse di studio per frequenza di academies regionali di livello internazionale in ambito ICT e digitale" ["Scholarships for attendance of regional academies of international level in ICT and digital"] D.D.n.206 of 20/07/2022 BURC n.64/2022;
- **CONSIDERING** that in response to the aforementioned Notice, the University of Naples Federico II presented the project DEFER Developers For Ever aimed at the implementation of highly qualifying training paths able to provide and strengthen digital skills and abilities of the recipients for an access or re-employment in the labor market;
- **GIVEN** the Executive Decree of the Campania Region No. 247 of 16/09/2022 by which the ranking list for the Public Notice "Borse di studio per frequenza di academies regionali di livello internazionale in ambito ICT e digitale" ["Scholarships for attendance of regional academies of international level in ICT and digital"] was approved;
- CONSIDERING that the Executive Decree No. 302 of 02/11/2022 the Project "DEFER Developers For Ever" has been admitted for funding from the PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5, for a total amount of € 8,400,000.00 (eight million four hundred thousand/00 euros);
- **CONSIDERING** the Convention between the University of Naples Federico II and the Campania Region signed on January 16, 2023 for the implementation of the project "DEFER -Developers for ever" (CUP E64C22001210006 - CML 22021PP0000001);
- **CONSIDERING** also that, for the academic year 2024/2025 it is expected that a total number of 300 students will be admitted to the Apple Developer Academy, of which 80 seats are for those who have already participated in companion Apple Programs, i.e., have attended the Apple Foundation Program, or the Apple Developer Academy in Brazil, Indonesia, Kingdom of Saudi Arabia, South Korea, or USA, or the iOS Development Lab in Mexico. This set of applicants will be collectively referred to as *"Apple Programs Participants"* in the remainder of this document.



# SECTION 1 (Announcement and number of seats)

As part of the project "DEFER - Developers for Ever" (CUP E64C22001210006 - CML 22021PP0000001) eligible for funding from PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5, the University of Naples Federico II announces a selection of 220 students to be admitted to the Apple Developer Academy.

The University reserves the right to increase the number of the students to a maximum of 300 in the event that the number of admitted students from the Apple Programs Participants announcement (Document reference: AppleDeveloperAcademyProgramsParticipantsCall\_24\_25) is lower than 80.

The selection refers to the academic year 2024/2025.

# SECTION 2 (Requirements for participation)

In order to be eligible for the selection mentioned in section 1, the applicant:

- must have a valid High School level diploma in their home country, issued by upper-secondary educational institutions. The diploma must have been earned within the scholastic year 2023/2024 or earlier;

- must be 18 years old by the Apple Developer Academy' starting date, September 23, 2024.

Candidates get a provisional admission to the selection. The University might decide to exclude any candidate, at any stage of this selection procedure, if the requirements are not fully met.

The applicants must not have already attended the Apple Developer Academy in Naples in the academic years 2016/2017, 2017/2018, 2018/2019, 2019/2020, 2021/2022, 2022/2023, 2023/2024.





# SECTION 3 (Application for participation in the selection procedure)

The application form must be submitted exclusively online through the following website: <u>www.developeracademy.unina.it</u>. The online registration is available since the publication date of this announcement, and will close mandatorily (and under penalty of exclusion from the selection procedure) **at 9am (GMT+1) of March 25<sup>th</sup> 2024**.

Failure to comply with the regulations described in section A.2 of Annex A will prevent the admission to the selection and, in any case, result in an exclusion from the procedure.

Applicants with disabilities who require assistance to carry out the selection procedure must select "yes" in the "participants with special needs" box and must send by March 18<sup>th</sup> 2024 at 9 a m (GMT+1) any request via e-mail to the following address: <u>developeracademy@unina.it.</u> This is compulsory in order to receive any care and support service, as described in section A.2 of Annex A.

All communications concerning the selection will be given exclusively via online publication on the Official Noticeboard of the University of Naples Federico II (available at the University website <u>www.unina.it</u>) and by publication on the website <u>www.developeracademy.unina.it</u>.

# **SECTION 4**

# (Evaluation Committee)

The Evaluation Committee will be appointed after the final deadline for submission of the participation applications. Its composition will be announced through a notice, published exclusively in the Official Noticeboard of the University (available at <u>https://www.unina.it</u>) and on the website https:// www.developeracademy.unina.it.

#### SECTION 5 (Selection procedure)

The admission exam will be in English and will consist of two phases:

- Assessment test
- Motivational interview



As better detailed in Section 6 of this document, the assessment test will take place online. Each applicant can take the exam just once.

Applicants who are admitted to the interview will be notified as described in section 7.

The selection procedure refers to section A.3 of Annex A, which is an integral part of this notice.

# SECTION 6 (Admission tests: date and place of the evaluation test – execution modalities – candidate's obligations)

#### Online tests

For this year's selection, the Apple Developer Academy is delivering written exams online.

The online tests will be delivered through an online examination platform, whose features and technical requirements will be described in detail in a dedicated page of the Apple Developer Academy web site (www.developeracademy.unina.it).

Online sessions will be scheduled between April 3<sup>rd</sup> and April 10<sup>th</sup>, 2024.

The schedule might be subject to changes. The up-to-date schedule will be published on the Apple Developer Academy web site (<u>www.developeracademy.unina.it</u>) and on the website of the University of Naples Federico II (<u>www.unina.it</u>).

The timetable of the tests will be announced exclusively via online publication on the Official Noticeboard of the University of Naples Federico II (available on the web site <u>www.unina.it</u>) and on <u>www.developeracademy.unina.it</u>. This timetable will be published no later than 5 days before the beginning of the exams.

Any information related to the admission test will be made public only via the above-mentioned means.

#### **SECTION 7**

#### (Admission test: date and place of the interview - implementation procedure)

The ranking list of the applicants admitted to the interview will be communicated exclusively by online publication on the Official Noticeboard of the University of Naples Federico II (available at <u>www.unina.it</u>) and by publication on the website <u>www.developeracademy.unina.it</u>.



Interviews will be scheduled between April 17<sup>th</sup> and April 24<sup>th</sup>, 2024. Interviews will take place online (via video conference), in accordance with the procedures mentioned in section A.3 of Annex A.

#### SECTION 8 (Publication of the ranking list)

The merit ranking list will be drawn up only based on the scores obtained in the assessment tests and in the interview.

In the event of a tie, the younger candidate shall prevail. The final ranking list will be published by May 7<sup>th</sup> 2024 on the Official Noticeboard of the University of Naples Federico II (available on <u>www.unina.it</u>) and on the website <u>www.developeracademy.unina.it</u>.

## SECTION 9 (Economic support funds)

Two hundred and Twenty (220) scholarships are provided for attendance to the Apple Developer Academy, which can be increased up to a maximum of 300, in the event that the number of students admitted through the selection procedure "Apple Programs Participants" (Ref: AppleDeveloperAcademyProgramsParticipantsCall\_24\_25) is less than 80, from the PR Campania ESF+ 2021-2027 Priority 2 "Education and Training", Specific Objective ESO 4.7, ACTION LINE 2.g.5.

The gross amount of each scholarship is  $\in$  7,777.78 (Euro seven thousand seven hundred and seventy-seven/78) corresponding to a gross percipient of  $\in$  7,168.46 (Euro seven thousand one hundred and sixty-eight/46), to be paid in the form of an Attendance Allowance provided that the participant has attended at least 80% of the total number of hours scheduled for the training course equal to 750.

## SECTION 10 (Procedure of acceptance)

The candidates admitted must formalize their attendance to the Apple Developer Academy by signing a declaration of acceptance by which the admitted person undertakes to comply with the provisions of this selection notice. The final date associated with the declaration of acceptance is set to May 17<sup>th</sup>, 2024.

Once the deadline for acceptance has expired, if there are any seats left due to lack of acceptance



or subsequent withdrawal, the ranking will be scrolled for candidates with a score of 70/100 or higher. The scrolling and the relative terms for making acceptances will be communicated exclusively by publication on the website of the University of Naples Federico II and on the Apple Developer Academy web site (<u>https://www.developeracademy.unina.it</u>).

## SECTION 11 (Access to documents, Information regarding personal data)

Applicants have access to documents concerning the competition procedure, in accordance with the current legislation. This right will be exercised in the manner prescribed by the University Regulations laying down the rules on administrative procedure and the right of access to documents, issued with the Dean Decree n. 2294/2010 and subsequent amendments and additions.

# SECTION 12 (Privacy and information on personal data)

In accordance with the art. 13 of the EU Regulation 679/2016, the personal data collected will be processed for the purposes of the procedure for which they are released and will be used exclusively for this purpose and in any case within the Institutional activities of the University. # SECTION 14 (Final Provisions)

The University reserves the right to exclude at any time the applicants participating in the procedure pursuant to this notice for failure to comply with its provisions or within the time specified or for default of the applicants' requirements. The exclusions are made with a Director Decree. Exclusions will be notified exclusively by online publication in the Official Noticeboard of the University of Naples Federico II (available at <u>www.unina.it</u>), as well as by publication of the exclusion decree on the website <u>www.developeracademy.unina.it</u>.
